CommonWell built a national interoperability infrastructure and person-centric network, focusing first on data exchange for treatment purposes and expanding across the care continuum into patient-driven and payment and operations data exchange. Core Services

CommonWell core services empower healthcare practitioners to manage patient identities, seamlessly link patients across organizations, and securely access, exchange, and receive clinical data beyond their own systems or communities.



Master Patient Index (MPI)

The MPI matches patients across care settings with both automated and manual options, ensuring accurate and scalable patient matching.



Record Locator Service (RLS)

The RLS links patients to their care locations and enables a single query to identify all the places where a patient has received care—essentially serving as a "virtual table of contents" for their health records.



Data Broker

The Data Broker enables users to query the CommonWell network and external frameworks to retrieve all of a patient's documents, eliminating the need for expensive point-to-point connections.



Trust Network

All CommonWell Service Adopters follow uniform rules, obtain certification, and enable data exchange for specific purposes, fostering trust and reliability across the network.
